By drawing on King & Shaxson’s strengths in fund management, active asset allocation and portfolio management the portfolios created using direct equity and bond holdings, investment trusts, property trusts, equity, bond, and forestry funds, plus microfinance and ETFs. The investment approach is to look through any underlying collectives to ensure a appropriate spread and diversity of underlying investments.

By using direct holdings as part of the portfolio we are able to benefit from higher returns on bonds and equities and minimise the internal portfolio costs whilst the more focused investment trusts and exchange traded funds still allow the portfolio to have an exposure to hundreds of underlying investments.

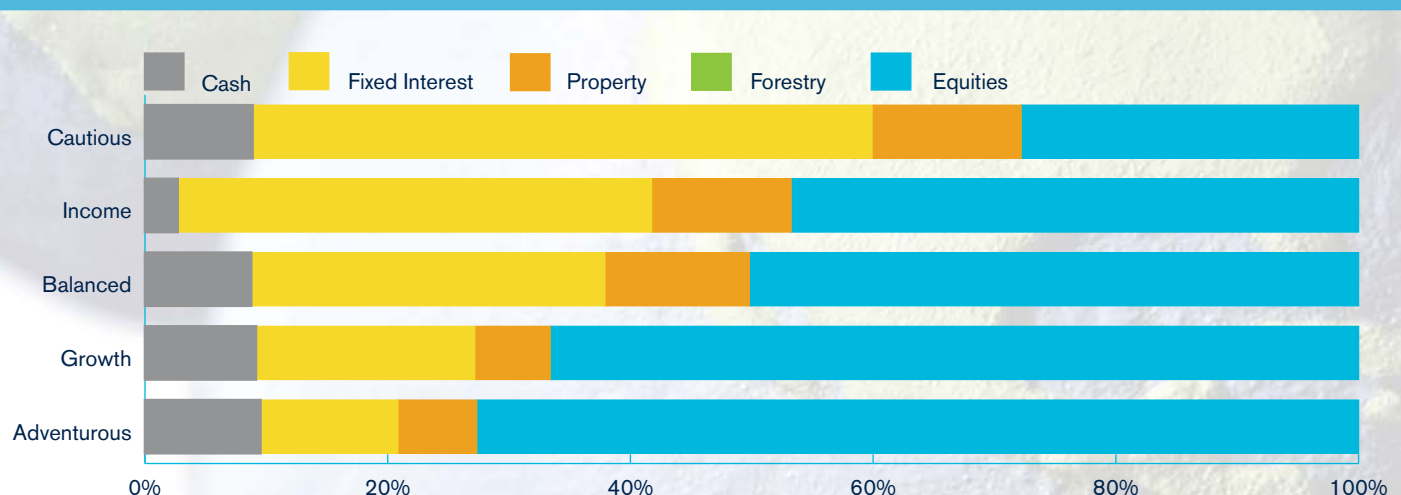
